Re: Marcus Conte v. The Brooklyn Hospital Center Case No. 10207504

Thank you Judge Linzer for today's Preliminary Conference, and to council for his or her kind concern about my mental anguishes in this case. It somehow became a referendum on my pain and suffering and even Medical Marijuana, but I'm glad we now move to the issue at hand, which is racism at The Brooklyn Hospital Center. I agree, Judge, this case is straightforward.

For basic transparency, and to defuse a potential ticking time bomb, first order of business is to compel Joshua Wright in some way suitable to your Honor to unveil his affiliations to radicalized organizations. To what degree was mister "Get your White privilege out of here" engulfed in his racist theory about white Americans? Is he alone in his actions or is he part of a collective? Since Joshua Wright now has a history of lying to the Division ["Do you have rights and privileges – get out of here"], a full-unedited search of his social media will most likely reveal his distorted views on race. What are the dangerous affiliations that caused Wright to bring his racism into the work place? Are there more 'security officers' like Wright at 'the hospital'?

And how can The Brooklyn Hospital Center prevent another Joshua Wright if they are unwilling or unable to reconcile his actions?

The big question is – was Wright's Neanderthal attack on a white reporter formulated at radicalized events he attended outside of the Hospital or at the Hospital itself, or both? Did Joshua Wright attend BLM rallies? If so, how many? Was the Hospital aware of it? Did the Hospital encourage this behavior? Did Joshua Wright attend any rallies or any social media events from 2014 to April 1, 2020 where there was talk about white police officers killing black people? George Floyd for example. At the time of this incident, 95% of black protest

rallies in the United States were generally peaceful. It was the other 5% that Joshua Wright fell in line with. The troublemakers.

I did extensive reporting on this issue [see attached Youtube Exhibits].

Did Joshua Wright have any prior knowledge, affiliation or understanding of any of the following cases that led to the race riots, looting and property damage we saw across the country? Did this curiosity lead to his own racial animosity? Was he following the lead of his comrades? Did he document and or post anything whatsoever on his social media about any of the following high profile cases?

July 17, 2014

Eric Garner died after he was wrestled to the ground by a New York police officer on suspicion of illegally selling cigarettes. While in a chokehold, Mr. Garner uttered the words "I can't breathe" 11 times. The police officer involved was later fired, but was never prosecuted. It came a year after the Black Lives Matter movement emerged in response to the acquittal of the man who killed teenager Trayvon Martin in Florida.

August 9, 2014

The killing of Michael Brown led to violent protests in Ferguson, Missouri. Michael Brown, 18, was killed by a police officer, in Ferguson, Missouri, who was responding to reports that Brown had stolen a box of cigars.

November 22, 2014

Tamir Rice, a boy of 12, was shot dead in Cleveland, Ohio by a police officer after reports of a male who was "probably a juvenile" pointing a gun that was "probably fake" at passers by.

April 4, 2015

Walter Scott was shot in the back five times by a white police officer, who was later fired and eventually sentenced to 20 years in prison.

July 5, 2016

Alton Sterling's death led to days of protests in Baton Rouge, Louisiana. Mr. Sterling was killed after police responded to reports of a disturbance outside a shop.

July 6, 2016

Philando Castile was killed while out driving with his girlfriend in St Paul, Minnesota. He was pulled over by the police during a routine check, and told them he was licensed to carry a weapon, and had one in his possession.

March 18, 2018

Stephon Clark died after being shot at least seven times in his grandmother's backyard in Sacramento, California, by police who were investigating a nearby break-in.

March 13, 2020

Breonna Taylor, a 26-year-old emergency medical technician, was shot eight times when officers raided her apartment in Louisville, Kentucky.

May 25, 2020

George Floyd died after being arrested in Minneapolis and held down by police officers, one of which had his knee on Mr. Floyd's neck for more than nine minutes.

In the event that Joshua Wright, or any co-conspirator of Joshua Wright testifies at the scheduled November 4th and 5th 2024 public Zoom hearing, these are the types of questions they will be asked.
